1. This constitutes an order for Wedding Day Photography, albums and/or prints.
2. Upon signature of both the Contracting Party (hereafter, **you**) and receipt of monetary deposit by Picture This Photography (hereafter, **PTP**), the photographer(s) of **PTP** reserve(s) the time and date agreed upon, and will make no other photography reservations for contracted time or date. For this reason, all deposits are non-refundable, even if the event date is changed or cancelled for any reason.
3. All fees and payments (including tax) are due no later than thirty (30) days prior to the contracted date. A \$50 fee will be added if this balance is not paid by the advance date. Final Payment Due Date: \_\_\_\_\_
4. It is understood that all negatives and/or digital images remain the property of **PTP**. Negatives and/or digital images may be purchased from **PTP**, but **PTP** reserves the right to use any of the photographs for advertising, display or any purpose considered proper and unobtrusive.
5. Due to copyright protection, after purchase and receipt of the photographs, digital scanning and reproduction by the client is understood to be illegal, unless Digital Image purchase is made by the client(s). Digital Images are defined as those supplied by **PTP** to the client on Compact Disc ("CD"). Restated: You may only make your own copies and prints of photos, or share them electronically, if you purchase the CD of photo files from **PTP**.
6. Although all care will be taken with the negatives, files and photographs created on the Wedding Day, **PTP** limits any liability for loss, damage or failure to deliver pictures for any reason to the return of all deposits and monies paid by you.
7. Candid photos of the ceremony, the reception and events included are encouraged by anyone with a personal or "table camera." However, it is understood that no other photographer, amateur or professional, shall be allowed to photograph the Wedding Day "Altar Shots" and/or other Formal Portrait Sessions, and that any breach of this agreement will constitute a reason for non-completion of the job with no liability to **PTP**, and will result in the loss of all payments by you.
