Contract Terms for Wedding Day Photography by PICTURE THIS PHOTOGRAPHY

This is a contract for photographic services to be provided to the Contracting Party (hereinafter "You" and "Your") by the photographer(s) of Picture This Photography (hereinafter "PTP") for the above selected package(s) and any extra services or products as outlined in the attached information sheet and online at: <http://www.pixthisphotos.com/2013Web/13WeddingBrochureP2.pdf>

Exclusive Photographer: Once this contract has been signed by You and PTP has received Your required deposit, PTP will reserve both the date (Wedding Date) and time (beginning one hour before Ceremony Time) agreed upon as written, and will make no other photography contracts for that date. For this reason, **all deposits are non-refundable**, even if the event date is changed or cancelled by You. Further, while guests may be allowed and encouraged to take candid photos of the ceremony, the reception, and events, it is understood and agreed upon by you that no other photographer, amateur or professional, may be allowed to photograph the Wedding Day "Altar Shots" and/or other Portrait Sessions and that **any breach of this will be considered cause for termination of the Agreement with no liability to PTP, and will result in the forfeiture of all monies paid by You to PTP. You will be the sole client of PTP for the day, and PTP will be Your sole professional still photographer.**

Fees and Payments: All fees and payments (including tax) are due no later than thirty (30) days prior to the contracted date (Wedding Date) as indicated below (Final Payment Due Date). A **\$100 fee will be added to any unpaid balance** after the Final Payment Due Date. **If payment in full (including any late fee) is not received** by PTP by the contracted date (Wedding Date), **all deposits will be forfeited** by you and **PTP will be under no obligation** to complete this contract.

Copyright: You acknowledge that PTP retains all rights to all images produced under this Agreement. With Your **purchase of a package that contains a DVD of photographic files and copyright release**, PTP agrees to grant you image rights with a non-exclusive, limited perpetual license. This license allows you to do the following: display the images; print the images; make "derivative" works of the images or otherwise modify them; edit or manipulate the electronic files; copy the electronic files or printed images; upload, email or otherwise electronically transfer the images or files; and publish the images on personal websites or social media websites. **This license prohibits You from:**
